We have one of the biggest programmes of works in the country, which reflects the level of risk being faced by the region, so this is an exciting opportunity for someone to support us and the Lead Local Flood Authorities by scrutinising the programme, identifying new partnerships which fund and deliver projects for communities at risk, and ensuring we are communicating well with all stakeholders.

The Southern RFCC oversees the delivery of locally and nationally significant schemes and projects across large parts of Hampshire, Isle of Wight, Sussex and Kent, including a significant coastline from Hurst Spit to the North Kent coast and parts of the Thames estuary.

## What are we looking for?

We are looking for individuals with enthusiasm and new ideas from one or more of the following backgrounds:

- Conservation
- Agriculture & Land Management
- Community Engagement and/or Flood Incident Management
- Partnership Funding & Contributions, Infrastructure and the Economy
- Media, Public Relations & Communications

Applicants do not need to be technical experts in flood and coastal risk management, though some understanding of the processes and impacts of flooding are desirable. More importantly, we need people who can think strategically; know how to engage and influence individuals, communities and networks; and understand the need for innovation and efficiency.

The Committee meets four times a year, though there may be additional meetings, workshops and site visits. These are unpaid roles but reasonable expenses, including travel, can be claimed. Our members are all appointed as impartial individuals in their own right and not as representatives of any particular organisation. We want to ensure our Committee represents the communities we serve and we welcome applicants from all walks
